### Which state is participating?

Entities that are members of the NASPO ValuePoint Cooperative Purchasing Program can participate. NASPO ValuePoint Cooperative Purchasing Program is a cooperative group-contracting consortium for state governments, serving their departments, institutions of higher education, agencies and political subdivisions (e.g. school districts, counties, cities, etc.). All 50 states, the District of Columbia, US Territories and other public entities may participate in the use of ValuePoint contracts.

### Who can initiate the process?

To start the process, a Participating Entity's Participating Addendum must be made as a part of the Master Agreement. A customer, TASC Systems' manufacturer representatives and dealers can initiate this process. Each participating addendum must be executed with TASC Systems in each state. An entity within the state may receive approval from the state to participate on their own if the state decides not to participate.
